INVITATION TO BID

Re-bidding for Provision of Custodial and Janitorial Services for C.Y. 2021

1. The Philippine National Oil Company (PNOC), through the 2021 Approved Corporate Operating Budget intends to apply the sum of **Three Million One Hundred Ninety Five Thousand One Hundred Twenty Three and 43/100 Pesos (PhP3,195,123.43)** being the Approved Budget for the Contract (ABC) to payments under the contract for *Provision of Custodial and Janitorial Services for C.Y. 2021* at PNOC Energy Supply Base, Mabini, Batangas with identification number IB 2021-06-114. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The PNOC now invites bids for the above Procurement Project. Delivery of Goods and Services is from July 1, 2021 to December 31, 2021. Bidders should have completed, within five (5) years from the date of submission and receipt of bids, a contract similar to the project. 3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "*pass/fail*" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.
