#### Scope of Works

2. The contractor shall collect, haul and dispose an accumulate volume of 35m<sup>3</sup> segregated garbage from PNOC Industrial Park (Hauling schedule: every quarter or as advised by the proponent.)
3. The contractor's worker shall undergo a Safety Orientation prior to the conduct of the activity and shall likewise abide with all HSSE policies of the Park
4. The contractor shall comply with the Labor requirements and all government rules and regulations on proper waste disposal
5. The contractor shall assume full responsibility and absolves the customer in part or in whole for any claims that may ensue from the contractor's act of disposing the customers garbage. Once the garbage is brought out of the Park, the garbage will be the contractor's sole responsibility
