KNOW ALL MEN BY THESE PRESENTS:

This Contract made and entered into this day of AUG 03 2023 2023 by and between:

PHILIPPINE NATIONAL OIL COMPANY (PNOC), a government-owned and controlled corporation duly organized and existing under and by virtue of Presidential Decree No. 334, as amended, with principal business address at PNOC Building 6, Energy Center, Rizal Drive, Bonifacio Global City, Taguig City, Metro Manila, represented herein by its President and CEO, **JESUS CRISTINO P. POSADAS**, and hereinafter referred to as the "COMPANY";

THE MARQUIS EVENTS VENUE BGC, INC., a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office at 2/F Active Fun Building, 9th Avenue Corner 28th Street, Bonifacio Global City, Fort Bonifacio, Taguig City, represented herein by its Senior Sales Executive, **CLARE RECLA-CATIMBANG**, duly authorized for this purpose and hereinafter referred to as "CONTRACTOR";

WITNESSETH:

WHEREAS, the COMPANY is in need of a Venue for PNOC's 50th Anniversary;

 4. Liquidated Damages is at least equal to one-tenth (1/10) of one percent (0.001) of the cost of the unperformed portion for every day of delay until actual delivery or performance.
 5. The terms of payment shall be as follows: *Net Thirty (30) calendar days upon acceptance and submission of Invoice/Billing.*
 6. The COMPANY hereby covenants to pay the CONTRACTOR the Contract Price or such other sum as may become payable under the provisions of the Contract.
