

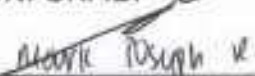

KNOW ALL MEN BY THESE PRESENTS:

This Contract made the _____ day of _____ 2024 between:

PHILIPPINE NATIONAL OIL COMPANY (PNOC), a government-owned and controlled corporation duly organized and existing under and by virtue of Presidential Decree No. 334, as amended, with principal business address at PNOB Building 6, Energy Center, Rizal Drive, Bonifacio Global City, Taguig City, Metro Manila, represented herein by the manager of the Administrative Department, **EFREN A. LEGASPI**, and hereinafter referred to as the "**COMPANY**";

-and-

MSDR WATER REFILLING STATION, a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office at 119 Manuel L. Quezon, Purok 2, New Lower Bicutan, Taguig City represented herein by its Owner, **MARK JOSEPH R. RAFAEL**, duly authorized for this purpose and hereinafter referred to as "**CONTRACTOR**";

WITNESSETH:

WHEREAS, the COMPANY is in need of a general contractor to undertake the Supply and Delivery of Drinking Water for eight (8) months (May 1, 2024-December 31, 2024). The COMPANY invited Bids for Supply and Delivery of Drinking Water and has accepted a Bid by the CONTRACTOR for the supply of those services in the sum of **ONE HUNDRED SEVENTY SIX THOUSAND THREE HUNDRED TWENTY PESOS (Php176,320.00)** which shall be paid within thirty (30) days from the presentation of billing statement (hereinafter called "the Contract Price"), inclusive of Value Added Tax (VAT), if any, and all applicable taxes, and in accordance with the terms and conditions set forth in this Contract;

NOW, THEREFORE, for and in consideration of the foregoing premises, and of the terms and conditions hereinafter set forth, the parties hereto agree as follows:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:

- a. Request for Quotation;
- b. Terms of Reference;
- c. Mayor's/Business Permit; and
- d. Notarized Omnibus Sworn Statement;
- e. Winning Bidder's quotation and all other documents or response to Supply and Delivery of Drinking Water;
- f. Notice of Award and the Bidder's Conforme thereof; and
- g. Notice to Proceed.

3. In consideration for the sum of ONE HUNDRED SEVENTY SIX THOUSAND THREE HUNDRED TWENTY PESOS (PHP176,320.00) or such other sums as may be ascertained, MSDR WATER REFILLING STATION agrees to the Supply and Delivery of Drinking Water.

4. The PHILIPPINE NATIONAL OIL COMPANY agrees to pay the above-mentioned sum in accordance with the terms of the Bidding

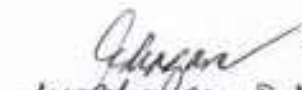
