





**CONTRACT FOR HAULING, TRANSPORT, TREATMENT AND DISPOSAL
OF HAZARDOUS WASTES OF PNOC INDUSTRIAL PARK**

KNOW ALL MEN BY THESE PRESENTS:

THIS CONTRACT made the _____ day of 01 JUL 2024 between:

PHILIPPINE NATIONAL OIL COMPANY (PNOC), a government-owned and controlled corporation duly organized and existing under and by virtue of Presidential Decree No. 334, as amended, with principal business address at PNOC Building 6, Energy Center, Rizal Drive, Bonifacio Global City, Taguig City, Metro Manila, represented herein by its Manager, Administrative Services Department, **ATTY. AROLF E. SUYOM**, and hereinafter referred to as the "**COMPANY**";

-and-

CLEAN LEAF INTERNATIONAL CORPORATION, a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with registered address at 232 Baesa Town Center, Quirino Highway, Quezon City, represented herein by Its President, **ATTY. EMILY G. CLAVERIA**, and hereinafter referred to as the "**CONTRACTOR**";

WITNESSETH:

WHEREAS, the COMPANY invited Bids for certain goods and ancillary services, particularly for the Hauling, Transport, Treatment and Disposal of Hazardous Wastes of PNOC-Industrial Park within Thirty (30) Calendar Days upon issuance of Permit to Transport (PTT) and has accepted a Bid by the CONTRACTOR for the supply of those goods and services in the sum of **ONE HUNDRED FOUR THOUSAND FIVE HUNDRED PESOS (Php104,500.00)**, inclusive of Value Added Tax (VAT) if any, and all applicable taxes, which cover all labor cost and cost of supplies, materials and equipment for the above specified services;

NOW, THEREFORE, for and in consideration of the foregoing premises, and of the terms and conditions hereinafter set forth, the parties hereto agree as follows:

1. In this Contract words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Contract, viz:







- (a) Request for Quotation/Proposal;
 - (b) Terms of Reference;
 - (c) Mayor's / Business Permit;
 - (d) Notarized Omnibus Sworn Statement;
 - (e) Winning bidder's quotation and all other documents or response to PNOC for the Hauling, Transport, Treatment and Disposal of Hazardous Wastes of PNOC Industrial Park
 - (f) Notice of Award; and the Bidder's conforme thereto; and
 - (g) Notice to Proceed;
3. In consideration of the payments to be made by the COMPANY to the CONTRACTOR as hereinafter mentioned, the CONTRACTOR hereby covenants with the COMPANY to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
 4. The CONTRACTOR shall assist the COMPANY in the application of Permit to Transport from DENR-EMB within Thirty (30) calendar days from receipt of Notice to Proceed.
 5. Ligated damages are One Tenth (1/10) of one percent (1%) of the cost of unperformed portion for every day of delay until actual delivery or performance.
 6. The COMPANY hereby covenants to pay the CONTRACTOR the contract price or such other sum as may become payable under the provision of the Agreement.

IN WITNESS WHEREOF, the parties hereto have caused this Contract to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


