CALAOR**, and hereinafter referred to as the "ENTITY";

3. In consideration for the contract price specified above, the CONTRACTOR agrees to the CONTRACT OF SERVICES FOR THE HIRING OF MUSICAL DIRECTOR FOR 2022 in accordance with his/her/its Quotation.

4. The ENTITY agrees to pay the above mentioned sum in accordance with the terms of the Bidding.


