

calendar days from instruction, inclusive of Value Added Tax (VAT) and all applicable taxes, and in accordance with the terms and conditions set forth in this Contract;

  - viii. Notice to Proceed;
  - ix. Other contract documents that may be required by existing laws and/or the entity
