

PHILIPPINE NATIONAL OIL COMPANY (PNOC), a government-owned and controlled corporation duly organized and existing under and by virtue of Presidential Decree No. 334, as amended, with principal business address at PNOC Building 6, Energy Center, Rizal Drive, Bonifacio Global City, Taguig City, Metro Manila, represented herein by Its President and CEO, **OLIVER B. BUTALID**, and hereinafter referred to as the "**COMPANY**";

DOMINGUEZ**, duly authorized for this purpose and hereinafter referred to as "**CONTRACTOR**";

WITNESSETH:

WHEREAS, the COMPANY is in need of a general contractor for the engagement of an Event Organizer for PNOC Mid-Year Rally 2025;

WHEREAS, the COMPANY requested for Quotations for the engagement of an Event Organizer for PNOC Mid-Year Rally 2025 and has accepted a Quotation by the CONTRACTOR for the supply of the services/goods in the sum of **ONE MILLION NINE HUNDRED SIXTY-SIX THOUSAND SIX HUNDRED SIXTY-EIGHT PESOS AND 20/100 (P1,966,668.20)**, inclusive of Value Added Tax (VAT) and all applicable taxes, (hereinafter referred to as "Contract Price"), on 2-4 July 2025; subject to mutual agreement between the service provider and PNOC upon issuance of Notice to Proceed (NTP);

NOW, THEREFORE, for and in consideration of the foregoing premises, and of the terms and conditions hereinafter set forth, the parties hereto agree as follows:


1. In this Contract words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) Request for Quotation
 - (b) Terms of Reference;
 - (c) Mayor's/Business Permit
 - (d) Winning Bidder's quotation and all other documents or response to PNOC for the for the engagement of an Event Organizer for PNOC Mid-Year Rally 2025;
 - (e) Notice of Award; and the Bidder's conforme thereof; and
 - (f) Notice to Proceed.
3. In consideration of the payments to be made by the COMPANY to the CONTRACTOR as mentioned herein, the CONTRACTOR hereby covenants with the COMPANY to provide the services in accordance with the terms and conditions set forth in this contract and to remedy any and all defects.






