

**CONTRACT OF SERVICES FOR THE REBIDDING FOR THE SUPPLY,
INSTALLATION, TESTING, AND COMMISSIONING OF POLE MOUNTED
TRANSFORMERS**

KNOW ALL MEN BY THESE PRESENTS:

This Contract made and entered into this **SEP 08 2025** day of _____
2025 by and between:

PHILIPPINE NATIONAL OIL COMPANY (PNOC), a government-owned and controlled corporation duly organized and existing under and by virtue of Presidential Decree No. 334, as amended, with principal business address at PNOC Building 6, Energy Center, Rizal Drive, Bonifacio Global City, Taguig City, Metro Manila, represented herein by its President and CEO, **OLIVER B. BUTALID**, and hereinafter referred to as the "**COMPANY**";

-and-

DANITECH POWER SYSTEM, INC., a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office at Block 11, Lot 15 A, Talisay St., Amparo Subd., North Caloocan City, represented herein by its Authorized Representative, **CARLO U. CASTILLO**, duly authorized for this purpose and hereinafter referred to as "**CONTRACTOR**";

WITNESSETH:

WHEREAS, the COMPANY is in need of supply, installation, testing, and commissioning of pole mounted transformers. The COMPANY invited Quotations for the supply, installation, testing, and commissioning of pole mounted transformers and has accepted a Quotation by the CONTRACTOR for the supply of those services in the sum of **TWO MILLION TWO HUNDRED TWENTY-FIVE THOUSAND FOUR HUNDRED SIXTY-NINE PESOS and 07/100 (PHP2,225,469.07)** which shall be paid within thirty (30) days from the presentation of billing statement (hereinafter called "the Contract Price") for the contract duration of sixty (60) calendar days from receipt of the Notice to Proceed (NTP), inclusive of Value Added Tax (VAT), if any, and all applicable taxes, and in accordance with the terms and conditions set forth in this Contract;

NOW, THEREFORE, for and in consideration of the foregoing premises, and of the terms and conditions hereinafter set forth, the parties hereto agree as follows:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

a. Philippine Bidding Documents (PBDs);

- i. Schedule of Requirements;
- ii. Technical Specifications;
- iii. General and Special Conditions of Contract; and
- iv. Supplemental or Bid Bulletins, if any.

b. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

c. Performance Security;

d. Notice of Award of Contract; and the Bidder's conforme thereto; and

e. Other contract documents that may be required by existing laws and/or the COMPANY concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of TWO MILLION TWO HUNDRED TWENTY-FIVE THOUSAND FOUR HUNDRED SIXTY-NINE PESOS and 07/100 (PHP2,225,469.07) or such other sums as may be ascertained, the CONTRACTOR agrees to supply, install, test, and commission the pole mounted transformers in accordance with its Bid.


4. The COMPANY agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




