This is regarding the shortlisting of consultants for the bidding of Procurement of Geodetic Surveying Services for PNOC Bataan Properties. The shortlisting for consultants is in compliance to Section 24 of RA 9184.

Six (6) bidders submitted eligibility documents. Five (5) bidders passed during the opening of eligibility documents, while one (1) bidder was declared ineligible.

Below is the result of the opening of eligibility documents and evaluation and shortlisting done by the End-User and Bids and Awards Committee (BAC) on the said eligibility documents:

1	Octantis Land Surveying	4.447	88.94%	Passed – Recommended for short-listing
2	Smartgeo Surveying and Geomatics	4.429	88.58%	Passed – Recommended for short-listing
3	Anaban Surveying Services Geomatics and Consultancy	4.422	88.44%	Passed – Recommended for short-listing
4	Habbiling and Associates land surveying Services	4.250	85 %	Passed – Not recommended for short-listing*
5	Asyana Construction Consultancy and Trading	-	-	Disqualified - Not compliant with the TOR which requires that a sole proprietor must be a licensed Geodetic Engineer.
6	Alterra Geomatics Construction	-	-	Ineligible – Submitted PhilGEPS Registration Certificate (Platinum Membership) without an updated eligibility document in Annex A, particularly the Audited Financial Statement.

\*Rating of 50% out of 100% (equivalent to a score from 2.50 to 5.0) will be passed for the Shortlisting, however, only the **top three** will be shortlisted.

Having passed and complied with all the requirements under Section 24 of RA 9184, the BAC recommends **Octantis Land Surveying, Smartgeo Surveying and Geomatics, Anaban Surveying Services Geomatics and Consultancy** to be shortlisted for the required Consultancy Service.

In its April 23, 2010 meeting, the PNOC Board of Directors as the Head of Procuring Entity (HOPE) delegated authority to the President and CEO to approve the shortlisting of consultants.

Upon approval, we will inform the said consultants of their shortlisting and proceed with the bidding process accordingly.
