**CONTRACT OF SERVICES FOR THE PREVENTIVE MAINTENANCE OF TWO
(2) UNITS PASSENGER ELEVATOR AT PNOC BUILDING 6**

KNOW ALL MEN BY THESE PRESENTS:

This Contract made the _____ day of 28 FEB 2025 2025 between:

PHILIPPINE NATIONAL OIL COMPANY (PNOC), a government-owned and controlled corporation duly organized and existing under and by virtue of Presidential Decree No. 334, as amended, with principal business address at PNOC Building 6, Energy Center, Rizal Drive, Bonifacio Global City, Taguig City, Metro Manila, represented herein by the Manager, Administrative Services Department, **AROLF E. SUYOM**, and hereinafter referred to as the "**COMPANY**";

-and-

KPI ELEVATORS, INC., a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office at 18th Floor, 1 Proscenium, Estrella Drive, Rockwell Center, Makati City, represented herein by Head of Sales, Maintenance Service & Modernization, **SALLY T. MUÑOZ**, duly authorized for this purpose and hereinafter referred to as "**CONTRACTOR**";

WITNESSETH:

WHEREAS, the COMPANY is in need of a general contractor to undertake the Preventive Maintenance Services of Two (2) Units Passenger Elevator at PNOC Building 6. The COMPANY invited Bids for Preventative Maintenance Services of Two (2) Units Passenger Elevator at PNOC Building 6 and has accepted a Bid by the CONTRACTOR for the supply of those services in the sum of **ONE HUNDRED EIGHTY SEVEN THOUSAND NINE HUNDRED SIXTEEN PESOS and 67/100 (Php187,916.67)** for a period of eleven (11) months from receipt of the Notice to Proceed, which shall be paid within thirty (30) days from the presentation of billing statement (hereinafter called "the Contract Price"), inclusive of Value Added Tax (VAT), if any, and all applicable taxes, and in accordance with the terms and conditions set forth in this Contract;

NOW, THEREFORE, for and in consideration of the foregoing premises, and of the terms and conditions hereinafter set forth, the parties hereto agree as follows:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
- (a) Request for Quotation;
 - (b) Mayor's/Business Permit;
 - (c) PhilGEPS Registration;
 - (d) Omnibus Sworn Statement
 - (e) Winning Bidder's quotation and all other documents or response to PNOC for the Preventive Maintenance of Two (2) Units Passenger Elevator at PNOC Building 6;
 - (f) Notice of Award; and the Bidder's conforme thereof; and
 - (g) Notice to Proceed.
3. In consideration of the payments to be made by the COMPANY to the CONTRACTOR as mentioned herein, the CONTRACTOR hereby covenants with the COMPANY to provide the services in accordance with the terms and conditions set forth in this contract and to remedy any and all defects.
4. Liquidated Damages is at least equal to one-tenth (1/10) of one percent (0.001) of the cost of the unperformed portion for every day of delay until actual delivery or performance.
5. The terms of payment shall be as follows: Refer to Detailed Terms of Reference attached herein as an integral part of the Contract.
6. The COMPANY hereby covenants to pay the CONTRACTOR the Contract Price or such other sum as may become payable under the provisions of the Contract.
