

KNOW ALL MEN BY THESE PRESENTS:

This Contract made and entered into this _____ day of _____

PHILIPPINE NATIONAL OIL COMPANY (PNOC), a government-owned and controlled corporation duly organized and existing under and by virtue of Presidential Decree No. 334, as amended, with principal business address at PNOC Building 6, Energy Center, Rizal Drive, Bonifacio Global City, Taguig City, Metro Manila, represented herein by its Manager, Administrative Services Department **ATTY. AROLF E. SUYOM**, and hereinafter referred to as the "**COMPANY**";

-and-

INFINITY LIFT INCORPORATED, a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office at Bambang ni Peles Street, Sta. Ana, Taguig City, Metro Manila, represented herein by its duly authorized and designated representative, **JOSELITO C. BUFETE**, duly authorized for this purpose and hereinafter referred to as "**CONTRACTOR**";

WITNESSETH:

WHEREAS, the COMPANY is in need of a general contractor for the Preventive Maintenance of Two Units Passenger Elevator at PNOC Building 5;

WHEREAS, the COMPANY invited Quotations for the Preventive Maintenance of Two Units Passenger Elevator at PNOC Building 5 and has accepted a quotation by the CONTRACTOR for the supply of those services in the sum of **NINETY-NINE THOUSAND PESOS (P99,000.00)**, inclusive of Value Added Tax (VAT) and all applicable taxes, (hereinafter referred to as "Contract Price"), to be complied within a period of Eleven (11) months from receipt of Notice to Proceed;

NOW, THEREFORE, for and in consideration of the foregoing premises, and of the terms and conditions hereinafter set forth, the parties hereto agreed as follows:

1. In this Contract words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) Request for Quotation;
 - (b) Terms of Reference;
 - (c) Mayor's/Business Permit; and
 - (d) Notarized Omnibus Sworn Statement;
 - (e) Winning Bidder's quotation and all other documents or response to PNOC for the Preventive Maintenance of Two Units Passenger Elevator at PNOC Building 5;
 - (f) Notice of Award; and the Bidder's conforme thereof; and
 - (g) Notice to Proceed.
3. In consideration of the payments to be made by the COMPANY to the CONTRACTOR as mentioned herein, the CONTRACTOR hereby covenants with the COMPANY to provide the services in accordance with the terms and conditions set forth in this contract and to remedy any and all defects.
4. Liquidated Damages is at least equal to one-tenth (1/10) of one percent (0.001) of the cost of the unperformed portion for every day of delay until actual delivery or performance.
5. The COMPANY hereby covenants to pay the CONTRACTOR the Contract Price or such other sum as may become payable under the provisions of the Contract.




