



**CONTRACT OF SERVICES FOR THE ENGAGEMENT OF CONSULTANCY
SERVICES FOR THE RETAIL ELECTRICITY SUPPLIER (RES) BUSINESS OF

KNOW ALL MEN BY THESE PRESENTS:

This Contract made and entered into this 15 day of JUL 2025
2025 by and between:

PHILIPPINE NATIONAL OIL COMPANY (PNOC), a government-owned and controlled corporation duly organized and existing under and by virtue of Presidential Decree No. 334, as amended, with principal business address at PNOC Building 6, Energy Center, Rizal Drive, Bonifacio Global City, Taguig City, Metro Manila, represented herein by its President & CEO, **OLIVER B. BUTALID**, and hereinafter referred to as the "**COMPANY**";

-and-

SMARTPOWER SOLUTIONS CORPORATION, a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office at 9 Illinois St., Barangay Silangan, Cubao, Quezon City, represented herein by its President, **MARVIN RYAN G. BATHAN**, duly authorized for this purpose and hereinafter referred to as "**CONTRACTOR**";

WITNESSETH:

WHEREAS, the COMPANY is in need of consultancy services for the Retail Electricity Supplier (RES) business of PNOC. The COMPANY invited Proposals for the consultancy services for the Retail Electricity Supplier (RES) business of PNOC and has accepted a Proposal by the CONTRACTOR for the supply of those services in the sum of **ONE MILLION SEVEN HUNDRED NINETY NINE THOUSAND NINE HUNDRED SEVENTY FOUR PESOS 40/100 (PHP1,799,974.40)** which shall be paid within thirty (30) days from the presentation of billing statement (hereinafter called "the Contract Price") for the contract duration of Two Hundred Ten (210) calendar days, upon issuance of Notice to Proceed (NTP), inclusive of Value Added Tax (VAT), if any, and all applicable taxes, and in accordance with the terms and conditions set forth in this Contract;

NOW, THEREFORE, for and in consideration of the foregoing premises, and of the terms and conditions hereinafter set forth, the parties hereto agree as follows:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.

2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:

- (a) General and Special Conditions of the Contract;
- (b) Terms of Reference;
- (c) Addenda and/ or Supplemental/ Bid Bulletins, if any;
- (d) Winning Bidder's Eligibility documents, Technical Proposals and Financial Proposals;
- (e) Notice of Award; and the Bidder's conforme thereof;
- (f) Notice to Proceed; and
- (g) Other contract documents that maybe required by existing laws and/ or the Company.

3. In consideration of the payments to be made by the COMPANY to the CONTRACTOR as mentioned herein, the CONTRACTOR hereby covenants with the COMPANY to provide the services in accordance with the terms and conditions set forth in this contract and to remedy any and all defects.

4. Liquidated Damages is at least equal to one-tenth (1/10) of one percent (0.001) of the cost of the undelivered and/ or unperformed portion for every day of delay until actual delivery or performance.

5. The terms of payment shall be as follows: Refer to Detailed Terms of Reference attached herein as an integral part of the Contract.

6. The COMPANY hereby covenants to pay the CONTRACTOR the Contract Price or such other sum as may become payable under the provisions of the Contract.




