

AROLF E. SUYOM**, and hereinafter referred to as the "**COMPANY**";

**XPLOR PHILIPPINES, INC.**, a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office at 563 Col Bonny Serrano Ave., Bayanihan Cubao, Quezon City, represented herein by its Project Manager, **JAKIELYN ANNE O. CRUZ**, duly authorized for this purpose and hereinafter referred to as "**CONTRACTOR**";

**WITNESSETH:**

**WHEREAS**, the COMPANY is in need of a general contractor for the Engagement of Training Provider/Subject matter expert for Digital Upskilling;

  - (e) Notarized Omnibus Sworn Statement;
  - (f) Winning Bidder's quotation and all other documents or response to PNOC for the Engagement of training Provider/Subject matter expert for Digital Upskilling;
  - (g) Notice of Award; and the Bidder's conforme thereof; and
  - (h) Notice to Proceed.
3. In consideration of the payments to be made by the COMPANY to the CONTRACTOR as mentioned herein, the CONTRACTOR hereby covenants with the COMPANY to provide the services in accordance with the terms and conditions set forth in this contract and to remedy any and all defects.
4. Liquidated Damages is at least equal to one-tenth (1/10) of one percent (0.001) of the cost of the unperformed portion for every day of delay until actual delivery or performance.
5. The COMPANY hereby covenants to pay the CONTRACTOR the Contract Price or such other sum as may become payable under the provisions of the Contract.
