PHILIPPINE NATIONAL OIL COMPANY (PNOC), a government-owned and controlled corporation duly organized and existing under and by virtue of Presidential Decree No. 334, as amended, with principal business address at PNOC Building 6, Energy Center, Rizal Drive, Bonifacio Global City, Taguig City, Metro Manila, represented herein by its President and CEO, **MA. CRISTINA SHEILA C. CABARABAN**, and hereinafter referred to as the "**COMPANY**";

HUMAN RESOURCE INNOVATIONS AND SOLUTIONS, INC. (HURIS), a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office at M3 Mezzanine Seven East Capitol Bldg., East Capitol Drive, Kapitolyo, Pasig City, represented herein by its Training Administration Specialist, **EL JEAN WYONA E. DRIZ**, duly authorized for this purpose and hereinafter referred to as "**CONTRACTOR**";

WHEREAS, the Entity invited Bids for certain goods and services, particularly the procurement of training provider/ subject matter expert for training course on knowledge management;

(d) Omnibus Sworn Statement
(e) Winning Bidder's quotation and all other documents or response to PNOC for the procurement of training provider/ subject matter expert for training course on knowledge management;
(f) Notice of Award; and the Bidder's conforme thereof; and
(g) Notice to Proceed.

3) In consideration of the Contract Price of **FOUR HUNDRED THOUSAND PESOS (PhP400,000.00)**, or such other sums as may be determined in accordance with the terms of the Contract, the Contractor agrees to deliver and perform the items and related services for the **PROCUREMENT OF TRAINING PROVIDER/ SUBJECT MATTER EXPERT FOR TRAINING COURSE ON KNOWLEDGE MANAGEMENT** described herein in accordance with the terms and conditions specified in the Contract and its annexed documents.
