**CONTRACT FOR THE PULLOUT, REPAIR AND REINSTALLATION OF
SUBMERSIBLE PUMPS AND MOTORS**

KNOW ALL MEN BY THESE PRESENTS:

This Contract made and entered into this _____ day of _____
2025 by and between:

PHILIPPINE NATIONAL OIL COMPANY (PNOC), a government-owned and controlled corporation duly organized and existing under and by virtue of Presidential Decree No. 334, as amended, with principal business address at PNOC Building 6, Energy Center, Rizal Drive, Bonifacio Global City, Taguig City, Metro Manila, represented herein by its President and CEO, **MA. CRISTINA SHEILA C. CABARABAN**, and hereinafter referred to as the "**COMPANY**";

-and-

GHIANNE'S PUMP EQUIPMENT REPAIR AND MAINTENANCE SHOP, a sole proprietorship duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office at 623 Purok 6, Brgy. Dampol, Plaridel, Bulacan, represented herein by its Proprietor, **MR. ROLANDO S. SORIA**, duly authorized for this purpose and hereinafter referred to as "**CONTRACTOR**";

WITNESSETH:

WHEREAS, the COMPANY is in need of a general contractor for the pullout, repair and reinstallation of submersible pumps and motors (PIP-25-133);

WHEREAS, the COMPANY invited Bids for the pullout, repair and reinstallation of submersible pumps and motors and has accepted a bid by the CONTRACTOR for the supply of those services in the sum of **FOUR HUNDRED TEN THOUSAND PESOS (Php410,000.00)**, inclusive of Value Added Tax (VAT) and all applicable taxes, (hereinafter referred to as "Contract Price"), mobilization shall begin within five (5) calendar days upon issuance of Notice to Proceed (NTP). The Repair Scope of Work, including the finalization and submission of the assessment and repair report shall be completed within fifty (50) calendar days from issuance of the NTP. The Pullout and Reinstallation Scopes of Work must each be completed within fifteen (15) calendar days upon issuance of Notice to Execute (NTE).

NOW, THEREFORE, for and in consideration of the foregoing premises, and of the terms and conditions hereinafter set forth, the parties hereto agreed as follows:

1. In this Contract words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) Request for Quotation;
 - (b) Terms of Reference;
 - (c) Mayor's/Business Permit;
 - (d) PhilGEPS registration;
 - (e) Notarized Omnibus Sworn Statement;
 - (f) Winning Bidder's quotation and all other documents or response to PNOC for the pullout, repair and reinstallation of Submersible Pumps and Motors;
 - (g) Bill of Quantities (BOQ);
 - (h) Notice of Award; and the Bidder's conforme thereof; and
 - (i) Notice to Proceed.
3. In consideration of the payments to be made by the COMPANY to the CONTRACTOR as mentioned herein, the CONTRACTOR hereby covenants with the COMPANY to provide the services in accordance with the terms and conditions set forth in this contract and to remedy any and all defects.
4. Liquidated Damages is at least equal to one-tenth (1/10) of one percent (1%) of the cost of the unperformed portion for every day of delay until actual delivery or performance.
5. The COMPANY hereby covenants to pay the CONTRACTOR the Contract Price or such other sum as may become payable under the provisions of the Contract.




