

KNOW ALL MEN BY THESE PRESENTS:

This Contract made the _____ day of 22 DEC 2025 2025 between:

PHILIPPINE NATIONAL OIL COMPANY (PNOC), a government-owned and controlled corporation duly organized and existing under and by virtue of Presidential Decree No. 334, as amended, with principal business address at PNOC Building 6, Energy Center, Rizal Drive, Bonifacio Global City, Taguig City, Metro Manila, represented herein by the President and CEO, **MA. CRISTINA SHEILA C. CABARABAN**, and hereinafter referred to as the "COMPANY";

-and-

DAMICO BUILDER AND SUPPLIES, a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office at Brgy, Parsolingan, Gerona, Tarlac, represented herein by its Owner/Manager, **MICHAEL J. DAVID**, duly authorized for this purpose and hereinafter referred to as "CONTRACTOR";


WHEREAS, the COMPANY is in need of a general contractor to undertake the rebidding for the rehabilitation of comfort room at main gate security building at PNOC Industrial Park.


WHEREAS, the CONTRACTOR has submitted a responsive bid and was awarded the contract for the procurement in the sum of **ONE MILLION FOUR HUNDRED NINETY FOUR THOUSAND FIVE HUNDRED SEVENTY ONE PESOS (P1,494,571.00)**, which shall be paid in accordance with the Terms of Reference (hereinafter called "the Contract Price"), inclusive of Value Added Tax (VAT), if any, and all applicable taxes, and in accordance with the terms and conditions set forth in this Contract;

NOW, THEREFORE, for and in consideration of the foregoing premises, and of the terms and conditions hereinafter set forth, the parties hereto agree as follows:

1. Unless otherwise stated, terms and expressions used in this Contract shall have the same meanings as those assigned to them in the Conditions of Contract, which form an integral part of this Contract.

2. The following documents as required by the Implementing Rules and Regulations of Republic Act No. 12009, and as applicable, shall form part and be read and construed as integral parts of this Contract, viz.:

a. Philippines Bidding Documents (PBD);

i) Invitation to Bid;

ii) Instruction to Bidders;

iii) Bid Form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

iv) Bid data Sheet;

v) Schedule of Requirements;

vi) Technical Specifications;

vii) General and Special Conditions of Contract;

viii) Supplemental Bid Bulletins, if any; and

ix) Other contract documents that may be required by existing laws and/or the Entity.

b) Winning bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted;

c) Performance Security;

d) Notice of Award of Contract; and the Bidder's Conforme thereto; and

e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBD, such as but not limited to the Notice to Proceed.

3. In consideration for the sum of ONE MILLION FOUR HUNDRED NINETY FOUR THOUSAND FIVE HUNDRED SEVENTY ONE PESOS (P1,494,571.00) or such other sums as may be determined in accordance with the terms of the Contract, DAMICO Builder and Supplies agrees to the Contract for the Rebidding for the Rehabilitation of Comfort Room at Main Gate Security Building at PNOC Industrial Park described herein in accordance with the terms and conditions specified in the Contract and its annexed documents.

4. PNOC agrees to pay the above-mentioned sum to the CONTRACTOR in accordance with the schedule and manner provided in the Bidding Documents and its annexes.

Any dispute, difference, or claim arising out of or relating to this Contract, including its existence, validity, interpretation, breach, or termination thereof, may be submitted to arbitration or other form of alternative dispute resolution in accordance with the applicable law, such as Republic Act No. 9285 (Alternative Dispute Resolution Act of 2004) or Executive Order No 1008, series 1985 (Construction Industry Arbitration Law).


