KNOW ALL MEN BY THESE PRESENTS:

This Contract made the 18 DEC 2025 2025 between:

PHILIPPINE NATIONAL OIL COMPANY (PNOC), a government-owned and controlled corporation duly organized and existing under and by virtue of Presidential Decree No. 334, as amended, with principal business address at PNOC Building 6, Energy Center, Rizal Drive, Bonifacio Global City, Taguig City, Metro Manila, represented herein by the President and CEO, **MA. CRISTINA SHEILA C. CABARABAN**, and hereinafter referred to as the "COMPANY";

-and-

PBOX Creative Advertising Corp., a corporation duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with office at 14 M.L. Quezon St., Parang, Marikina City, represented herein by its Sales Manager, **JONALYN L. VARGAS**, duly authorized for this purpose and hereinafter referred to as "CONTRACTOR";

WHEREAS, the COMPANY is in need of a general contractor to undertake the supply and installation of PNOC Outdoor Façade Signage at the Energy Center.

WHEREAS, the CONTRACTOR has submitted a responsive bid and was awarded the contract for the procurement in the sum of **THREE HUNDRED SIXTY EIGHT THOUSAND THREE HUNDRED SEVENTY ONE AND 4/100 PESOS (P368,371.04)**, which shall be paid in accordance with the Terms of Reference (hereinafter called "the Contract Price"), inclusive of Value Added Tax (VAT), if any, and all applicable taxes, and in accordance with the terms and conditions set forth in this Contract;

NOW, THEREFORE, for and in consideration of the foregoing premises, and of the terms and conditions hereinafter set forth, the parties hereto agree as follows:

1. Unless otherwise stated, terms and expressions used in this Contract shall have the same meanings as those assigned to them in the Conditions of Contract, which form an integral part of this Contract.

2. The following documents as required by the Implementing Rules and Regulations of Republic Act No. 12009, and as applicable, shall form part and be read and construed as integral parts of this Contract, viz.:

- a. Request for Quotation;
- b. Mayor's/Business Permit;
- c. PHILGEPS Registration;
- d. Omnibus Sworn Statement;
- e. Notice of Award and the Bidder's Conformance;
- f. Notice to Proceed; and
- g. Winning bidder's quotation and all other documents or response to PNOC for the procurement of supply and installation of PNOC outdoor façade signage at the Energy Center.

3. In consideration for the sum of THREE HUNDRED SIXTY EIGHT THOUSAND THREE HUNDRED SEVENTY ONE AND 4/100 PESOS (P368,371.04) or such other sums as may be determined in accordance with the terms of the Contract, PBOX Creative Advertising Corporation agrees to the Contract for Supply and Installation of PNOC Outdoor Facade Signage at the Energy Center described herein in accordance with the terms and conditions specified in the Contract and its annexed documents.

4. PNOC agrees to pay the above-mentioned sum to the CONTRACTOR in accordance with the schedule and manner provided in the Bidding Documents and its annexes.

5. Any dispute, difference, or claim arising out of or relating to this Contract, including its existence, validity, interpretation, breach, or termination thereof, may be submitted to arbitration or other form of alternative dispute resolution in accordance with the applicable law, such as Republic Act No. 9285 (Alternative Dispute Resolution Act of 2004) or Executive Order No 1008, series 1985 (Construction Industry Arbitration Law).


