  - (g) Notice of Award; and the Bidder's conforme thereof; and
  - (h) Notice to Proceed.

In consideration of the Contact Price aforementioned or such other sums as may be determined in accordance with the terms of the Contract, the Contractor agrees to deliver and perform the items and related services for the Supply and Delivery of Network Firewall Appliance with Software described herein in accordance with the terms and conditions specified in the Contract and its annexed documents.
