**CONTRACT FOR CONSULTANCY SERVICES –
SAFETI/PHAST CONSULTANT**

KNOW ALL MEN BY THESE PRESENTS:

This Contract made the _____ day of 27 AUG 2026 2026 between:

PHILIPPINE NATIONAL OIL COMPANY (PNOC), a government-owned and controlled corporation duly organized and existing under and by virtue of Presidential Decree No. 334, as amended, with principal business address at PNOC Building 6, Energy Center, Rizal Drive, Bonifacio Global City, Taguig City, Metro Manila, represented herein by its President and CEO, **FRANZ JOSEF GEORGE E. ALVAREZ**, and hereinafter referred to as the "**PNOC**";

-and-

ENGR. ALDWIN A. CAMANCE, single, of legal age, with residence address at 0749 C St. Luke's Drive Palmera IV, Dolores (POB), Taytay, Rizal, hereinafter referred to as the "**CONSULTANT**";

WITNESSETH:

WHEREAS, the PNOC requested for proposal for certain consulting services particularly the procurement of SAFETI/PHAST Consultant;

WHEREAS, the CONSULTANT submitted a responsive proposal and was awarded the contract for the procurement in the total amount of **THREE HUNDRED FIFTY THOUSAND PESOS (Php350,000.00)**, hereinafter referred to as the "Contract Price," inclusive of Value Added Tax (VAT) if any, and all applicable taxes, in accordance with the terms and conditions set forth in this Contract, within one hundred eighty (180) calendar days upon receipt of Notice to Proceed (NTP);

NOW, THEREFORE, for and in consideration of the foregoing premises, and of the terms and conditions hereinafter set forth, the parties hereto agree as follows:

1. Unless otherwise stated, terms and expressions used in this Contract shall have the same meanings as those assigned to them in the Conditions of Contract, which form an integral part of this Contract.

2. The following documents as required by the Implementing Rules and Regulations of Republic Act No. 12009, and as applicable, shall form part and be read and construed as integral parts of this Contract, viz:
- a) Bidding Documents:
 - i) Request for Quotation/Proposal;
 - ii) Terms of Reference;
 - iii) Mayor's/Business Permit or BIR Certificate of Registration;
 - iv) Price Quotation/Proposal and Compliance Form;
 - v) PhilGEPS Registration Number;
 - vi) Detailed Curriculum Vitae (CV); and
 - vii) Other contract documents that may be required by existing laws and/or the PNOC.
 - b) Winning consultant's proposal including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted;
 - c) Notice of Award of Contract; and the Bidder's Conforme thereto; and
 - d) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBD, such as but not limited to the Notice to Proceed and Warranty Security.
3. In consideration of the Contract Price of **THREE HUNDRED FIFTY THOUSAND PESOS (Php350,000.00)**, or such other sums as may be determined in accordance with the terms of the Contract, the CONSULTANT agrees to deliver and perform the items and related services for the Consultancy Services - SAFETI/PHAST Consultant described herein in accordance with the terms and conditions specified in the Contract and its annexed documents.
4. The PNOC agrees to pay the above-mentioned sum to the CONSULTANT in accordance with the schedule and manner provided in the Bidding Documents and its annexes.
5. PNOC and the CONSULTANT acknowledge that this engagement serves as an update and continuation of the Quantitative Risk Assessment (QRA) and PHAST SAFETI modeling services performed by the Consultant in 2019. The Consultant engages in this Contract strictly as an independent contractor. Furthermore, PNOC expressly authorizes the Consultant to utilize the foundational knowledge, general methodologies, and insights acquired during the 2019 engagement to fulfill the current project objectives, subject to any prevailing confidentiality agreements.

6. Any dispute, difference, or claim arising out of or relating to this Contract, including its existence, validity, interpretation, breach, or termination thereof, may be submitted to arbitration or other form of alternative dispute resolution in accordance with the applicable law, such as Republic Act No. 9285 (Alternative Dispute Resolution Act of 2004) or Executive Order No 1008, series 1985 (Construction Industry Arbitration Law).
7. Liquidated Damages is at least equal to one-tenth (1/10) of one percent (1%) of the cost of unperformed portion for every day of delay until actual delivery of performance.

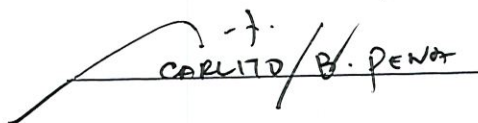
